
- A description of the type and number of animals to be kept
- A description of the coop or shelter type (If purchasing from a store, please provide a picture)
- Feed storage container location and type
- Location, method, and schedule of manure storage and disposal
- Any other relevant information related to keeping the animals, if requested by the Administrative Officer

Site Plan Requirements for Chicken, Duck, and Rabbit Zoning Compliance Applications

- Please see the following page for site plan examples
- Two (2) copies minimum size of 8.5"x11" paper, maxiumum size of 11"x17" paper
- North arrow and scale (i.e. 1 inch = 20 feet)
- Property lines, with the exact dimensions of the lot labeled
- The exact dimensions and location of all existing buildings (house, shed, barn, etc.), structures (decks, patios, pools, paved parking areas, courtyards, etc.) and driveways/access points, indicating setbacks of each from property lines with measurements/distances labeled
- The exact location and setbacks from property lines and structures of all private water and wastewater treatment facilities
- Location of coop or shelter with all setbacks from property lines indicated. (If using a portable coop or shelter, indicate the yard area in which the coop or shelter will be kept.)
- Location and manner of containment of outdoor areas with all setbacks from property lines indicated. (If using a portable containment system, indicate the yard area in which the system will be kept.)
- All fence locations
- Any other information with regard to the lot or neighboring lots which may be necessary to determine and provide for the enforcement of the Franklin County Zoning Resolution
 - Please note that the requirements mentioned above, or portions of, may be waived by the Administrative Officer when, in his/her opinion, the applicant has satisfactorily demonstrated that all aspects relative to the above have been suitably addressed

Drawing a Site Plan for a Chicken, Duck, and Rabbit Zoning Compliance Application (example shown on page 4)

- The applicant (property owner) may prepare the required site plan provided all applicable requirements are detailed and it is drawn to an appropriate scale. However, staff reserves the right to require that the site plan be prepared by a design professional (i.e. registered surveyor, engineer and/or architect) as provided per Section 705.022 of the Franklin County Zoning Resolution. Site plans which are incomplete and/or not drawn to scale will <u>not</u> be accepted.
- Site plans may be created digitally or drawn by hand using a scale or ruler and a straight edge. Scales of 1'' = 20', 1'' = 30', 1'' = 40' and 1'' = 60' are provided below.







Site Plan Requirements

- North arrow and scale (i.e. 1 inch = 20 feet)
- Property lines with the exact dimensions of the lot labeled
- Location of fencing, if applicable
- Location of compost, if applicable
- The exact dimensions and location of all existing buildings with setbacks to property lines indicated

*These site plan examples are for reference purposes only.

Sheltering Structure & Outdoor Areas

- Location Requirements
 1) Be located in a side or rear yard.
 2) Be located at least 10 feet from any property line.
- Properties smaller than 1 acre must screen sheltering structures and outdoor areas. Fences used for screening must be 6 feet tall, 100% opaque, and made of wood or other similar opaque fencing material. No chain link fences are permitted.
- Any outdoor areas accessible to chickens, ducks, or rabbits must be secured to keep animals on the property.
- Any structure over 65 square feet must comply with Accessory Building Standards (see section 512 of the Franklin County Zoning Resolution).
