2022 ACTION PLAN FOR HOUSING &  
URBAN DEVELOPMENT FUNDS

Franklin County, Ohio will conduct two public hearings and two technical assistance workshops soliciting citizen input and project proposals for its 2022 annual action plan submission to the U.S. Department of Housing & Urban Development (HUD). The Action Plan describes the City's one year, planned use of Community Development Block Grant, HOME and Emergency Solutions Grant program resources administered by the County and its subrecipients (the County anticipates receiving \$3.1 million from these HUD categorical grant programs in 2022.) The plan requires approval by the Board of County Commissioners and will be submitted to HUD no later than sixty (60) days after the County is informed of its 2022 HUD allocations.

The two technical assistance and citizen input workshops will both be held at 150 S. Front Street, Suite 10 in the south conference room: 9 - 11 a.m. on Friday, October 8th and 6:00 - 8:00 p.m. on Thursday, October 7th, 2021. The public hearings on the draft action plan will also be held at the Front Street address, 9 - 11 a.m. on Friday, January 14, 2022 and from 6:00 - 8:00 p.m. on Thursday, January 13, 2022. Applications will be made available on the Franklin County web site at [www.co.franklin.oh.us](http://www.co.franklin.oh.us) by September 11th, 2015 or by calling Mark Paxson in the Department of Economic Development & Planning @ (614) 525-5578 (after logging onto the County website click on Economic Development & Planning; and then from there Community Development to find the application.) Additionally, individual technical assistance is available by contacting Mr. Paxson and scheduling a meeting.
