

AN ORDINANCE TO PETITION THE COUNTY COMMISSIONERS OF FRANKLIN COUNTY, OHIO FOR ANNEXATION OF APPROXIMATELY 3.779 ACRES OF LAND, LOCATED ON COSGRAY AND SHIER-RINGS ROADS, TO THE CITY OF DUBLIN
